Short title and Commencement.	1.	(1)	These rules may be called the Himachal Pradesh Local Audit Department, Junior Auditor, Class-III Recruitment and Promotion (Second Amendment) Rules, 2016.
		(2)	These rules shall come into force from the date of publication in the Rajparta, Himachal Pradesh.
Amendment of the column 9 of Annexure-"A".			<p>In Annexure-"A" to the Himachal Pradesh Local Audit Department, Junior Auditor, Class-III Recruitment and Promotion Rules, 2008 :</p> <p>For the existing provisions against column No 9, the following shall be substituted, namely:-</p> <p>(i) <u>Direct Recruitment:</u></p> <p>(a) Two years subject to such further extension for a period not exceeding one year as may be ordered by the competent authority in special circumstances and reasons to be recorded in writing.</p> <p>(b) No probation in case of appointment on contract basis, tenure basis, re-employment after superannuation and absorption.</p> <p>(ii) <u>Promotion:</u></p> <p>(a) No probation in case of promotion.</p>
